# Minutes of North Cotes Parish Council Meeting held on Tuesday 11<sup>th</sup> May 2021 at 7.30pm at North Cotes Village Hall

**MINUTES OF THE LAST MEETING** – The minutes of the previous meeting were read and approved.

### 2. MATTERS ARISING

- **2.1 Local Elections** It was noted that Conservative candidate Councillor Daniel McNally had retained his seat in the local elections and that the Police and Crime Commissioner Elections were won by Conservative Candidate Marc Jones. Congratulations were noted for both.
- **2.2 Parish Councillor Elections -** Nominations were needed for the Council Officers for the forthcoming year.

Mrs W van der Horst proposed that Mr A Hicks continue as Chair, this was seconded by Mrs A Marsh and carried unanimously.
Mr A Hicks proposed that Mrs Wendy van der Horst continue as Vice Chair, seconded by Mr F Brearley and carried unanimously.

- **2.3** Rural Safety Partnership Speed Watch Scheme Update No further updates or news. No police meetings have taken place and due to the current pandemic.
- 2.4 Village Hall/Church update Currently there are no church services due to the current situation. The church is unable to open due to not having any running water, as well as there being no current vicar. There was an issue with grass cutting for the Church and a request for volunteers to cut the grass has been made. It was noted that the Village Hall's business rates had gone unpaid for 2 years. It was agreed that the full amount owing should be paid immediately to avoid further costs but that we should look into getting a rate relief. It was agreed that the Charity Commission should be made aware of the current issue with the Village Hall with regards to current funds and accounts not being completed for over 2 years.

**Action:** Parish Clerk to contact ELDC – Business rates & to contact Charity Commission

- **2.4.1 Village Hall Committee** A new committee was formed at this meeting. A date would now be set for the committee to meet and take the hall forward
- **2.5** Overview of Crime update it was currently quiet, but all villagers should remain vigilant and report any incidents
- 2.6 Trust Houses It was noted that the Parish Clerk had taken over as Clerk to the Trust Houses. An update to the Trust Houses will be provided at future Council meetings. A new committee was formed and a meeting date would be arranged. Action: Parish Clerk to arrange a suitable meeting time/date for the new committee.
- **2.7 Road Markings White Lines –** A member of the public requested that central white lines should be marked on the road on the way into the village. **Action:** Parish Clerk to contact Highways

- **3.1 Planning Permission South View (amended)** It was noted that the planning application had been amended slightly, but the Parish Council views still remained the same as the previous application
- **3.2 Donation Request** It was noted that a donation request of £10 had been received from Lowland Search. The committee was in unanimous agreement that the suggested donation be made to this worthy cause.
